Treasurer's Financial Summary

December 31, 2016

Revenues:

- December revenues totaled \$1,254,021; the revenue this month was primarily from the state foundation settlement.
- Year-over-year revenues are up from last December. This is due to the increase in revenue from the state and the timing of a payment from a revenue sharing agreement with the City of Reynoldsburg.
- This December's revenue is up 28.8% from last December.

Expenditures:

- December expenditures totaled \$3,614,010; salaries and benefits made up 79.8%. This is due to December being a month with three payrolls. Purchased services made up an additional 17.2% of the expenditures. This is much lower than the prior December because of the timing of a large payment that we had made to the ESCCO on Dec. 30th, 2015.
- Year-to-date expenditures should be approximately 50% of forecasted expenditures with six (6) months in the books and total expenditures are at 54%. This is because we have had 14 of our 26 pays in the first six months.
- Year-over-year expenditures look how we would expect this month.
- Forecasted expenditures for fiscal year 2017 are \$37,219,143 resulting in an only a 0.5% increase due to savings from healthcare changes. We will continue to monitor expenditures closely ensuring we are maintaining forecast goals.

Overall:

- December revenues were under expenditures by \$2,359,990. The current general fund balance is \$4,523,297.
- Based on the October 2016 forecast we are headed toward deficit spending in fiscal year 2018 in the amount of \$2,448,149. This year we expect revenue to outpace expenditures by \$420,316.
