## Treasurer's Financial Summary December 31, 2015

#### Revenues:

- December revenues totaled \$973,608; revenue sources included state foundation settlement, revenue sharing with Cities of New Albany and Reynoldsburg and student fees;
- Year-over-year revenues are up 5.5% mainly due to increases in state support and a one-time settlement with Reynoldsburg City School District;
- Forecasted revenues for fiscal year 2016 are \$36,878,747 resulting in a 3% increase mainly due to additional state support and collection of one-time settlement payments.

#### **Expenditures:**

- December expenditures totaled \$3,918,887. Year-over-year salaries and benefits are up 16.2% and 14.8%, respectively, due to salary step increases, new employees and health insurance premium increases.
- Year-to-date expenditures should be approximately 50% of forecasted expenditures with one-half of fiscal year completed and total expenditures are at 51.3%;
- Year-over-year expenditures have increased 15.0% due to salary step increases, new employees and health insurance premium increases.
- Forecasted expenditures for fiscal year 2016 are \$38,428,907. We will continue to monitor expenditures closely ensuring we are maintaining forecast goals.

#### Overall:

- December revenues were under expenditures by \$3,342,394 due to timing of receiving revenue sources. The current general fund balance is \$3,918,887.
- The forecast reflects a negative operating year for the District at \$1,550,160 which reduces the fund balance to nearly \$3,785,861.
